The AER addresses the complex reporting information required by federal and some requirements of state laws. Our staff is available to help you understand this information. These reports contain the following information:

Teacher Qualification Data

- Identifies the number and percentage of inexperienced teachers, principals, and other school leaders Reports teachers who are teaching with emergency or provisional credentials
- Includes teachers who are not teaching in the subject or field for which they are certified

NAEP Data (National Assessment of Educational Progress)

- Provides state results of the national assessment in mathematics and reading every other year in grades 4 and 8

Civil Rights Data

- Provides information on school quality, climate and safety

Review the table below listing our schools. For the 2020-2021 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no status label is given.

TSI – The school has at least one subgroup performing in the bottom 25% within each applicable accountability index component.

ATS – The school has met the criteria for TSI identification and has at least one subgroup performing at the same level as a CSI school.

Teachers and leaders across the district are supporting a continuous school improvement process to increase the quality of instruction, raise the expectations for learning, and ultimately increase overall student achievement. Our focus continues to be on data analysis and highly effective instructional practices. Staff use a universal data protocol process to guide instructional decision making, identify areas of student need, and improve curriculum.

Holly Area Schools has earned the distinction of AdvancED Systems Accreditation. This Systems Accreditation reflects the ongoing commitment to our school improvement initiatives that we support each day to ultimately improve the impact of teaching and learning for our students. There are many layers to the efforts and progress currently happening at Holly Area Schools.
